FAQ about each option	<b>Market Rate</b>	<b>Price Cap \$1.989</b>	<b>Pre-Buy \$1.889</b>
<b>Is there an enrollment Fee?</b>	No fee. The price you pay is the current market price at the time of delivery. This price may fluctuate along with the market. This does not require enrollment.	Yes, a \$25.00 enrollment fee is due with your signed heating season agreement if you choose the price cap option.	No fee. The Pre-Buy plan allows you to lock in fuel prices for the heating season without paying an extra fee. You make one up-front payment for the gallons you need.
<b>Will this option protect me if market prices increase?</b>	No, this price follows the market and will increase if market prices increase.	Yes! You will be protected as propane prices rise. Your price per gallon will not exceed \$1.989 through March of 2025	Yes! In addition to locking in the quantity you have pre-bought at \$1.889 this option also protects you with the price cap rate if pre-bought gallons are used up before March 31 <sup>st</sup> of 2025. <b>Bonus!</b>
<b>Are there propane usage Requirements?</b>	No, there are no usage requirements.	Yes, customers must use at least <b>500 gallons per heating season</b> to qualify for the price cap.	Yes, customers must use at least <b>500 gallons per heating season</b> to qualify for the pre-buy program. The minimum quantity you can buy for this option is also 500 gallons.
<b>What if I pre-buy more gallons than I end up using?</b>	Not applicable.	Not applicable.	Any pre-bought gallons left after March 31 <sup>st</sup> on customer accounts will be refunded at \$1.889.

**TERMS AND CONDITIONS**

Tri-Gas will have no liability to fixed price customers or prepaid customers or any other person for delays in performance or change to the guaranteed fixed price due to strike, or labor disputes of any types; accident, fire, floods, acts of God; closure or damage to Enbridge Line 5, or actions by governmental authorities; acts, omissions, or delays of customer or any other third parties; shortages of labor; or without limitation of the above, for any causes reasonably beyond the control of Tri-Gas Company.

Tri-Gas will not send a propane truck up an un-plowed driveway or un-sanded incline even if you have pre-bought and are on keep full. Our propane trucks will need to navigate your driveway to make a delivery – which is impossible if the way is blocked by snow and ice. Keeping your driveway plowed (and sanded, if it is steep) will ensure that we can access your propane tank. Please also remember that our delivery trucks are wider than standard cars, so shoveling just a narrow path may not be adequate. If our delivery person is unable to navigate your driveway, we will not be able to fill your tank, which could result in a special delivery fee. If you will be away for the winter, please consider having your driveway & tank checked regularly.
